PLEASE READ CAREFULLY - Carolina Bowling Showcase Rules

Rules of USBC and Carolina Bowling Showcase as stated herein, will govern this tournament and participants. The Tournament Committee

has the right to resolve all questions and disputes arising. The Tournament Committee's decisions shall be final and binding. THE TOURNAMENT COMMITTEE RESERVES THE RIGHT TO MODIFY TOURNAMENT FORMAT AND RULES AS DEEMED FAIR, APPROPRIATE AND NECESSARY.

1. Carolina Bowling Showcase is open to all USBC-Certified bowlers. Entrants must show a current USBC Card at check-in. PBA "STANDARD" members are eligible to participate, but cannot bowl together as original or additional partners. PBA "FULL" members (or if you have won a Regional or National title) are not allowed to participate. Host center employees are allowed to participate, but may not bowl together as original or "alibi" partners. Carolina Bowling Showcase Tournament Committee members are not allowed to participate.

2. Entry deadline is September 25, 2010. No reservation will be processed with the proper fees attached. Only Certified Checks, Money Orders or Cash will be accepted (No Personal Checks or Credit Cards). No refunds will be made after the entry has been received and scheduled to bowl. Entry form must show full names, addresses, USBC number and & average of each bowler. Each entry must indicate a time choice. Out-of-town entries will be given time preferences. Team captains must check-in one (1) hour prior to squad times. Replacements may be made only at this time. Replacements must bowl in the position of the original entrant. The Tournament Committee reserves the right to reject any entry and entry fee. WALK-INS and RE-ENTRIES (Fee = \$25.00 per person) will be accepted until the close of the tournament, based on lane availability. Tournament Committee reserves the right to add additional squads as deemed necessary and appropriate.

3. AVERAGES: All participants must provide accurate average for their highest USBC-certified average for the year (2009-2010), regardless of hand. If a bowler has no USBC-certified average for the past year, the bowler must provide average verification of their highest current average based on 33 or more games. VERIFICATION: Association average books or secretarial verification will be accepted. Any Bowler without a certified average will be considered a scratch bowler and receive no handicap. USBC Rule 319-A2 (Ten-Pin Rule) does not apply. IT SHALL BE EACH BOWLER'S RESPONSIBILITY TO VERIFY THE ACCURACY OF THE SUBMITTED AVERAGE, NO MATTER WHO SUBMITS THE AVERAGE. IF AN ENTRANT SUBMITS AN AVERAGE LESS THAN HIS\HER TRUE AVERAGE, HE\SHE SHALL FORFEIT ALL PRIZE MONEY (AND ANY HE(SHE HELPED TO WIN) AND SHALL BE DISQUALIFIED. Average corrections must be made by the end of the first game bowled. RE-RATE: The Tournament Committee reserves the right to refuse any entry or re-rate the average of any bowler whose average does not reflect the bowler's ability. If a bowler's average is re-rated, the bowler has the right to decline the re-rate prior to bowling, and receive a refund of entry fees paid. USBC Rule on reporting prize winnings of \$600 or more does apply. Failure to provide actual score, position and amount won at time of entry will result in disqualification and forfeiture of entry fees.

4. HANDICAP RATIO: 80% of the difference between bowler's average and 200. Females: 50 pins max \ Males: 40 pins max

5. FORMAT: Once an event is started, no make-up frames will be allowed for tardy bowlers. Zero score will be given for all frames missed. TEAM EVENT participants will bowl three (3) games on the same pair of lanes. Team Event participants are not required to participate in other events. Team Participants may re-enter multiple times, but NO MORE THAN TWO (2) MEMBERS OF A PRIOR TEAM MAY RE-ENTER TOGETHER. SINGLES\DOUBLES (Hdcp) EVENT PARTICIPANTS MUST ENTER BOTH EVENTS THE FIRST TIME THEY BOWL. SINGLES WILL BE BOWLED FIRST. Participants may re-enter Singles events multiple times, but may cash only once. Doubles may consist of any combination. Participants may re-enter Doubles events multiple times, but may cash only once with the same partner (including alibis). ALL-EVENTS participants must pay for and participate in the Team, Doubles and Singles events to be eligible for All-Events Awards. All-Events standings will be based on the participant's first scores bowled in Team, Doubles and Singles.

DOUBLES ALIBIS: Bowlers may pay an additional \$20.00 fee, to pair their scores with another bowler, on a different team, on the same squad.

6. PRIZE FUND will be returned 100% based on estimated entries. Distribution of prize money will be based on a ratio of at least 1 for every 10 entries. EXCEPT in All-Events where the ratio will be at least 1 for 20. If estimated number of entries for guarantees is not met, Tournament Committee reserves the right to determine prize fund breakdown as deemed appropriate and fair. Prize money will be mailed to Team Captain no later than 30 days after close of tournament. All prize awards will be considered final, as published by the Tournament Committee. Bowlers will not be allowed to forfeit any winnings. No legal action for prize money may be brought after prize monies are issued.

7. Automatic scorers will be used to compute scores. Any corrections to scores during tournament play must be made and/or verified by a tournament official. Scores will be recorded on printed score sheets and bowlers will be responsible for his/her scores to be written down correctly by another bowler, with the competitor's name and signature indicated as the scorer. BOWLERS CANNOT RECORD THEIR OWN SCORES. In event of lane mechanical failure, Tournament Committee reserves the right to move bowlers at their discretion. NO REFUNDS WILL BE ISSUED.

8. DRESS CODE & PERSONAL CONDUCT: Proper attire shall include shirts with sleeves, dress slacks or jeans, and dress shorts. NO tank tops, jean shorts, "Short" shorts, cut-offs, spandex, dresses or hats. No obscene attire. All issues regarding appropriate attire will be decided upon by tournament management. Profanity, cheating or abuse of equipment will not be allowed. No smoking permitted in the bowler's area. ONLY PARTICIPATING BOWLERS SHOULD BE SEATED IN THE BOWLER'S AREA NEAREST TO THE LANES.

The Tournament Committee reserves the right to disqualify any entrant not in compliance with the rules of the tournament and USBC. Premature termination of the tournament brought about by war, national emergency or emergency causes relating to; fires, strikes, lockouts, labor difficulties, weather or other reasons beyond the control of Carolina Bowling Showcase Tournament Committee shall cause, to the extent required thereby, all prizes to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
