## TOURNAMENT RULES

1. Entries are open to all female members of the Greater Charleston USBC Association.
2. All prize fees will be returned 100%
3. Entrants will use their highest USBC average as a regular bowler or a substitute bowler in the following order:
  - End of the 2007-2008 winter season; 21 games or more
  - End of the 2008 summer season; 21 games or more
  - Average as of January 31, 2009; 21 games or moreBowlers who do not meet any of these requirements shall automatically be entered with a 200 average in each event.
4. Handicap shall be based on 80% of 200.
5. Teams in this tournament shall consist of 4 members. Prizes will be awarded on a handicap basis. Scratch team, doubles, singles and scratch all-events awards will be given, provided the scratch event fee has been paid.
6. There will be one (1) prize for each five (5) entries in handicap and scratch team, doubles and singles. Handicap all-events will pay one (1) prize for each ten (10) entries. Scratch all-events will pay one (1) prize for each five (5) entries. Scratch prizes will be available for an additional \$5.00 per event (an additional \$20.00 for all scratch events). **All members of a team / doubles pair must pay to be eligible for the scratch prizes. Bowlers must be entered into the handicap division to enter the scratch division this includes A/E.**
7. Reserved entries must be received prior to the closing date of **February 23, 2009**. Walk-in entries must be present one hour prior to squad time to verify lane availability with the tournament director. Bowlers may re-enter as many times as desired subject to USBC Rule 315 Team event-not more than two (2) players on one (1) team can place more than once in the prize list for position standings. Doubles event-in no case shall the same two (2) players on a doubles team be permitted to place more than once in the prize list for position standings. Singles event-in no case shall the same individual be permitted to place more than once in the prize list for position standings).
8. If entered in doubles, bowlers must also enter in singles and vice-versa on their original entry.
9. Team Captains must check in their teams 30 minutes prior to their scheduled time to bowl.
10. If a bowler is late, the bowler receives a score of zero for each frame missed. A substitute bowler may be entered at this time. Substitutes will bowl in the position of the bowler being replaced
11. The Board of Directors of the GCUSBA shall have the right to hear and decide on all protests arising during the tournament. Any protest affecting eligibility or playing rules must be confirmed in writing to the Tournament Director within twenty four (24) hours.
12. The 10 Pin rule does not apply to this tournament (Rule 319.a2).
13. Appropriate dress code will be enforced: No Mini Skirts or Short Shorts. No Halter Tops or Tank Tops
