1. This is a NON-sanctioned handicapped tournament; however, USBC rules will govern this tournament.
2. Entry fee is \$25.00 per person. Entry fee breakdown is as follows: Lineage \$9.40, Prize Fee \$7.80, Courageous Kids® \$7.80.
3. Handicap will be computed on the basis of 80% of the difference between the bowler's average and 220.
4. Entering Average Rule:
 - a. Highest USBC sanctioned winter league average for the 2008-09 winter season.
 - b. If no 2008-09 winter average then use the highest 2008-09 summer league average, minimum of 21 games. The Association Manager will verify.
 - c. If neither a. nor b. applies then use the current season average as Saturday, May 15, 2010, minimum of 21 games will be used. League Secretary will verify.
 - d. If none of the above applies then a scratch average of 220 will be used.
5. All bowlers are cautioned to be familiar with USBC Rule 319e concerning average adjustment. NOTE: The ten (10) pin rule will not apply in this tournament.
6. The prize ratio will be one (1) cash award per seven (7) entries.
7. Tournament prize money will not be awarded until the winner's averages have been verified by the Tournament Director.
8. Team Captains must check in thirty (30) minutes before squad time. Substitutions may be made at this time. There will be no changes in the team line-up unless substitutions are involved.
9. Entries will be on a first come, first serve basis. The first 32 entries will bowl at Noon (12:00pm). If more entries are received, they will bowl at 4:00pm.
10. If bowler is 18 years of age or younger AND still in school, parents or legal guardians must sign a consent form and be sent in with entry form. This is due to possible scholarship implications. **USBC SANCTIONED YOUTH BOWLERS ARE INELIGIBLE FOR THIS TOURNAMENT.**
11. **Teams will consist of a minimum of one (1) person from each gender.**
12. Entry fee MUST accompany the entry form. Please send check or money order made out to North Charleston Mayor's Cup Tournament.
13. Errors in posted scores must be reported to the Tournament Director within twenty-four (24) hours after posting.
14. All prize fees will be returned 100% in the event from which collected.
